Note: 08th February, 2025 (Second Saturday) is working day in lieu of public holiday declared on 1st January, 2025.

The regular teaching staff can be permitted to avail eight (08) days of casual leave during calendar year 2025 and ten (10) special casual leaves for the purpose of (a) conducting examinations of a University/Public Service Commission, etc. (b) inspection of academic institutions for the academic year (July-June). In case of contract (Teaching and Non-Teaching), twelve (12) days of Casual Leave may be granted. The regular non-teaching employees are entitled for sanction of twenty (20) days of casual leave in the calendar year 2025. The Outsourcing employees are also entitled for sanction of twelve (12) days of Casual Leave in a year. Further, the regular women employees (Teaching & Non-Teaching) can be permitted to avail five (05) more casual leaves in addition to their respective entitlement during the calendar year 2025.
